

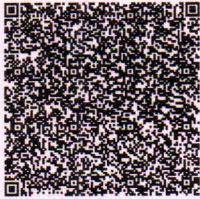

This **Memorandum of Understanding** is executed and entered into force on this day of February, 2022 at Dibrugarh University.

BETWEEN

KHOWANG COLLEGE, a provincialized College affiliated to Dibrugarh University established in the year 1982 and having its registered office at Khowang College campus, Khowang-ghat, Dibrugarh, Assam represented by the Principal, Khowang College.

AND

JOGAMAYA BORAH MEMORIAL EDUCATION TRUST SOCIETY (herein after referred to as JBMETS), a Socio-Cultural and Educational Non-Government Organization having its Head Office at No.2 Digholia Village, P.O. Ouphulia Chari Ali & P.S. Rajgarh, District- Dibrugarh, Assam represented by its Secretary, Dr. Binud Chandra Borah, **JOGAMAYA BORAH MEMORIAL EDUCATION TRUST SOCIETY.**

I) PURPOSE & OBJECTIVES:

Khowang College as a Centre of Higher Education in the state of Assam committed for all-round development of its stakeholders and for that purpose aims to collaborate with the other institutions and organizations of repute to materialize these objectives. As a part of this holistic objective, the College enters into this Memorandum of Understanding (MoU) with JBMETS, who is willingly coming forward to collaborate with the College in organizing a Memorial Lecture in the name of the Founder Principal Late Shiva Kumar Singh as an annual function of the College.

II) ROLE AND RESPONSIBILITIES OF THE INSTITUTIONS:

A. The JBMETS shall be responsible for–

- (i) extending support in selection and invitation of the Invited Speaker(s) for the Lecture(s) and also in selection of the theme of the lecture(s),
- (ii) bearing expenses related to travelling and accommodation of the Invited Speaker(s),
- (iii) bearing expenses related to felicitation and honorarium of the Invited Speaker(s) and Distinguished Guest(s).
- (iv) extending support in publicity and invitation of guests.

B. KHOWANG COLLEGE shall be responsible for–

- (i) initiating the process for selection and invitation of the Invitation of Speaker(s) for the Lecture(s) and also selection of topic for the lecture(s),
- (ii) coordinating and managing the publicity and invitation of the guests,
- (iii) arranging halls and other facilities for the programme with all necessary amenities,
- (iv) arranging local hospitality and refreshment for the guests,
- (v) coordinating and managing the agenda of the programme(s),

(III) FINANCIAL Responsibilities:

The JBMETS shall bear the financial involvements for the activities mentioned at Clause II(A) above, whereas the financial involvements for the activities mentioned at Clause II(B) shall be borne by Khowang College.

Any other matter related to smooth organization of the Memorial Lecture but not covered by the clauses above shall be addressed by both the Parties with mutual cooperation and understanding.

(IV) TERMS AND VALIDITY OF MOU:

- (i) The term of the MoU will be normally for five (05) years from the date of signing which will be renewed on mutual agreement after completion of its term unless terminated earlier.
- (ii) The MoU may be terminated by either party by providing 90 days written notice. However, in the event of termination by either parties, the students already admitted in course shall remain unaffected and both the parties will be bound to complete the course and declare results accordingly.
- (iii) The MoU can be amended in writing by mutual consent of both of the parties.






