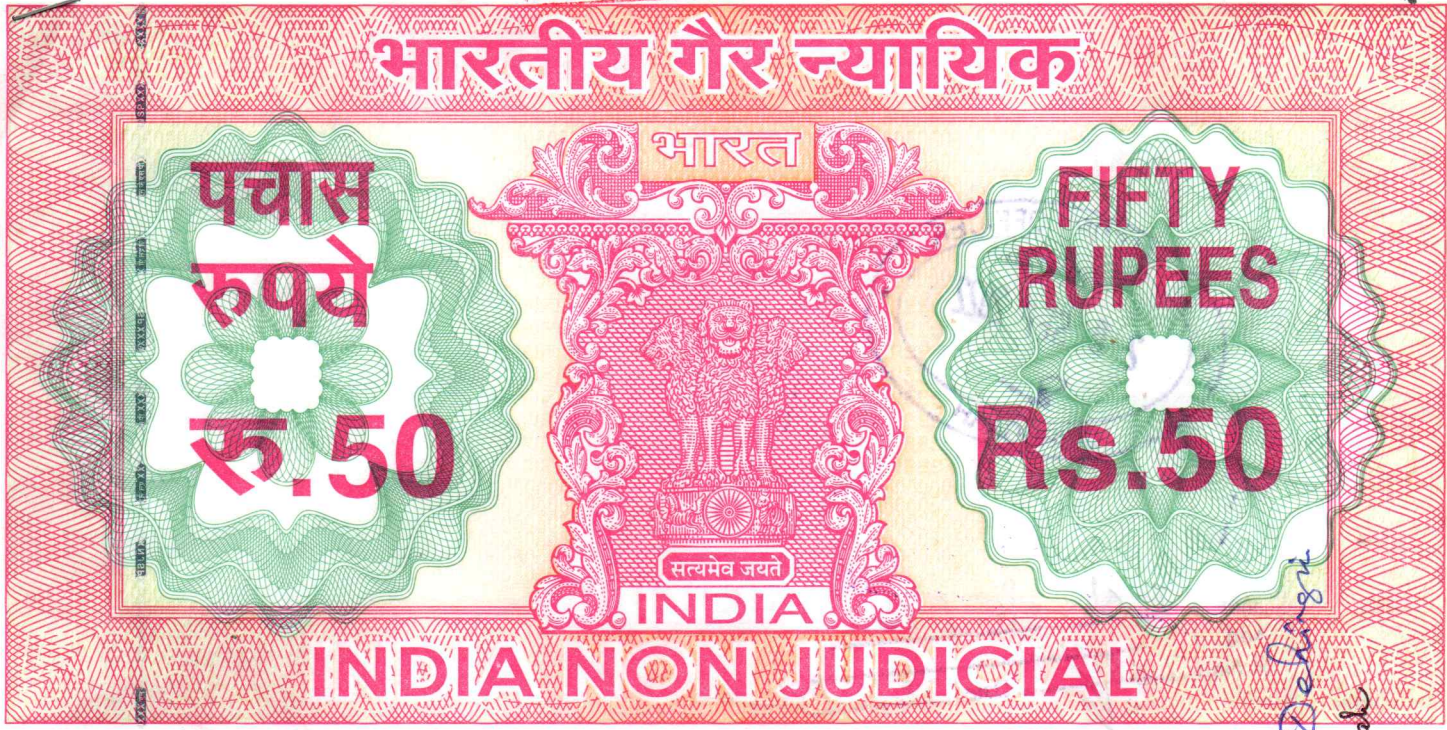

PITHUBAR GIRLS' DEGREE COLLEGE, P.O., P.S. Khowang & Dibrugarh, Assam-785675 (which expression shall unless it be repugnant to the context or meaning thereof shall mean and include his heirs, legal representatives, executors, administrators and assigns) of the OTHER PART/SECOND PART.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

A. Aims and Objectives:-

The MoU aims at fostering collaboration and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit and frequent interactions Khowang College and Pithubar Girls' Degree College agree and which are as follows:-

- a) To exchange information on research and educational programmes.
- b) To exchange information on teaching, learning material and other literature relevant to their educational and research programmes.
- c) To jointly organize short-term educational programmes on topics of mutual interest and to invite each other's faculty to participate therein.
- d) To jointly organize seminars, conferences or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- e) To jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein.
- f) To exchange, on a reciprocal basis, students at undergraduate levels for limited period of time for purpose of education and/or research.

WHREAS ALSO Khowang College and Pithubar Girls' Degree College further agree that detailed terms and conditions that guide such activity identified above will be separately determined and agreed upon by the two institutions.

B. Joint Sponsored Research and Development:-

Khowang College and Pithubar Girls' Degree College agree to help, identify and invite faculty members from the other institution to participate in research or development programmers.

C. Exchange of Faculty:-

Khowang College and Pithubar Girls Degree College agree to encourage collaboration between faculty members from the two institutions. Specifically, both the institutions will encourage their faculty members to undertake short visits to take up foxed-term visiting assignments at each other's institution as per the existing norms and terms and Conditions for each visitor undertaking any of the above mentioned assignments, including those concerning stipend, travel and housing, name of the concerned faculty member, etc. will be worked out between Khowang College and Pithubar Girls' Degree College

D. Student Exchange:-

Khowang College and Pithubar Girls' Degree College agree that students from both the institutions will visit each other's institution for study related purpose and will join courses of their choice in the respective insitution. Students of both the institutions will collaborate indacation and research works together.

E. Tenure and Termination:-

This MOU will take effect from the date it is signed by representatives of the two institutions. It will remain valid or five years and may be continued thereafter subsequent to suitable review and agreement.

F. Settlement Clans:-

If there is any dispute regarding any aspect of academic cooperation, signing authorities of both the institutions will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

This MOU (Memorandum of Understanding) is signed subject to approval of the respective academic administrative bodies.
